### Requirements

The applicant for producer membership agrees to the following:

1. It mines industrial sand within the State of Texas;
2. It is committed to responsible industrial sand mining and environmental stewardship;
3. It will look toward industry best practices in areas such as environmental, health, and safety;
4. It is dedicated to open and honest dialogue with stakeholders impacted by its mining facilities;
5. It has adopted the National Industrial Sand Association's (NISA) Silicosis Prevention Program, does currently and will continue to conduct dust sampling and medical surveillance for silicosis as outlined in the NISA Occupational Health Program manual;
6. It has received and read ISPOT's anti-trust policy and will abide by the terms of our anti-trust policy in connection with any ISPOT activity.

**Dues**

Producer Membership: Dues are assessed on a calendar year basis, and are uniform across the organization from producer to producer. In calendar year 2019, dues amount to \$20,000 per year. After July 1, dues for the remaining calendar year will be prorated. Producer membership comes with a seat on the organization’s Board of Directors. The Board reserves the right to request special assessments for specific initiatives.

Associate Membership: Dues are assessed on a calendar year basis, and are uniform across the organization from associate member to associate member. In calendar year 2019, dues amount to \$1,000 per year. After July 1, dues for the remaining calendar year will be prorated.

**Modifications**

The dues, membership requirements, and NISA documents may be subject to change from time to time, and the applicant agrees to abide by any revised terms and conditions.
